The general feeling of those present was that the 66ft. right of way for private roads is reasonable, and the ordinances should stay as written. Again further discussion should take place on this important issue when the Zoning Administrator and all members are present. Copies of the Township of Ford River Land Division Act were also handed out for review by the members of the commission as an aid in Co-ordinating the private road permit requirements for the Zoning Ordinance and the Land Division Ordinance.
