c. Landscape quotes. The board decided it would be more cost-effective to replace the existing lawn mower with a new one. Quotes were provided at the April 2019 meeting. It was decided to go with Northgate provided they would still honor this price as the quote was only valid for 30 days. There was a suggestion of trading in old mowers and/or replacing the mower at water tower with old one from Hall.

The Discussion to pay sexton the additional \$100.00 for burial. Clerk will look into paperwork necessary to change pre-pay of burial. Board wants any pre-pay to have a balance due if rates increase before the actual burial.
