# Ford River Township Planning Commission Regular Meeting minutes Meeting date May 1, 2014

Public Hearing – John Adrihan – gusmithing

Public hearing opened at 7:03.

Public comment about concern about grandkids

Comment about extra activity in the area.

Reply by Mr. Adrihan – he has a six year old and is very safety conscious.

- -The business is not a retail operation and has few customers.
- -The business is primarily mail order. He does not sell guns.
- -He needs to test fire the guns when they are fixed generally two to six shots. The guns are loaded with a wax bullet, not a regular cartridge.

Could the test firing be done at a range? – no there may be a need to make adjustments after firing.

A question was raised concerning granting of a special use permit violating state law. The Planning Commission is required to follow the our own Township ordinance. A latter was presented with this concern.

CUPPAD was contacted and stated that gunsmithing does fall under Home Occupation. The specific activity could be added to the ordinance, but it is impossible to list everything. Home Occupation is different than starting and industrial business.

Mr. Adrihan was asked if there would be a problem maintaining a 7:00am. To noon quiet time (no shooting.) He said that would be no problem.

The Planning Commission went through the requirements of 604 – General requirements – see attached vote sheet.

A citizen commented that there should be a discussion – if desired – of each 604 item before it was voted on. A discussion was called for each item.

A motion was made to approve the Special Use Permit with the 7:00am. to Noon noise restriction Motion by Mt. Tryan, second by Mr. Lippens. Unanimous approval. Public Hearing closed 7:35pm.
