We are getting a quote for geothermal heat for the township and fire halls. They guessed at about \$30,000 with a possible 70% tax credit.

Nancy Mathews hired Brunette's to fix the leak in her water line. She hired them for \$600. They are not a licensed plumber so it will be her responsibility to pay the bill. The meter is not in front of her property so she feels it is our responsibility. Charlie checked with MTA and our township ordinance on this issue and the customer is responsible for their own service line. Nancy would also like the meter moved to the front of her property. Cost would be approximately \$4,000.
