## WATER SYSTEM BUSINESS

Well #1 has been demolished and we are still waiting for Kleiman's to complete the abandonment. It was postponed due to the pump falling to the bottom of the well. As per the DEQ, we are not required to remove it.

Well #2 pump will be replaced later this fall.

GEI is working on the General Plan requirements.

The exposed river crossing will be a lengthy and possibly very costly problem. The water division would like us to remove the old river crossing and replace it. Jeff will insulate and barricade it for the winter to protect it. He will also work on having it grandfathered and then paperwork for "re-stabilizing" the river bank instead of removing and replacing the river crossing. Rory Matson has been helping Jeff and Rachael with this problem.
