  - c. J. Church would like to know why the Water Dept charges \$25.00 per month when water is turned off. It was discussed that it is a charge for sustaining our system that everyone that has water available has to contribute to. If a customer wants off the system, they will have to pay to have the connection removed.

- d. Community foundation. Information on grants available to township is available through the Community Foundation. Supervisor has card if we ever feel it is a need for Township.
- e. Spectrum. Need faster internet.

Motion, A. Wagner, support, D. Brown, CARRIED to upgrade Spectrum to \$149.00 per month plus a \$99.00 install and have the phone included.

- f. Al Couillard/DNR Property. Al would like it put on the record that our Water operator treated him unprofessionally. He feels it was uncalled for.

  Mr. Couillard is inquiring about purchasing DNR property. Supervisor feels we don't have enough information to make a decision on this tonight, but understands Mr. Couillard only has a few days to decide on the property. He will ask the DNR to put a hold on the sale until more research can done. R. Scott asks for a drawing of water lines in that area if we are going to discuss this again.
- g. Cemetery sexton has resigned. He was upset about hornets in the shed. G. LaFave is available to dig for cremations and N. Wagner can dig for full burial until the Township can find someone. Supervisor will run an ad.
