2022 Water Quality Report for FORD RIVER TOWNSHIP

Water Supply Serial Number: 2350

This report covers the drinking water quality for Ford River Township, for the calendar year 2022. This information is a snapshot of the quality of the water that we provided to you in 2022. Included are details about where your water comes from, what it contains, and how it compares to Environmental Protection Agency (EPA) and state standards.

Your water comes from two groundwater wells **#2** and **#3** that are each 660 feet in depth. The State performed an assessment of our source water in 2003 to determine the susceptibility or the relative potential of contamination. The susceptibility of well #1 was very high, while #2 and #3 are rated very low. Well #1 was abandoned in 2011.

- Contaminants and their presence in water: Drinking Water, including bottled water, may reasonably be expected to
 contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that

- Vulnerability of sub-populations: Some people may be more vulnerable to contaminants in drinking water than the
 general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons

- Sources of drinking water: The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. Our water comes from wells, as water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- **Microbial contaminants**, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- **Inorganic contaminants**, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture and residential
- Radioactive contaminants, which are naturally occurring or be the result of oil and gas production and mining activities.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of
 industrial processes and petroleum production, and can, also, come from gas stations, urban stormwater runoff,
 and septic systems.

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration regulations establishes for contaminants in bottled water which provide the same protection for public health.



Ford River Water Quality Data

The table below lists all the drinking water contaminants that we detected during the 2022 calendar year. The presence of these contaminants in the water does not necessarily indicate that the water poses a health risk. Unless otherwise noted, the data presented in this table is from testing done January 1 through December 31, 2022. The State allows us to monitor for certain contaminants less than once per year because the concentrations of these contaminants are not expected to vary significantly from year to year. All the data is representative of the water quality, but some are more than one year old.

Terms and abbreviations used below:

Maximum Contaminant Level Goal (MCLG)

The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Maximum Contaminant Level (MCL):

The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

• Maximum Residual Disinfectant Level (MRDL):

The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

• Maximum Residual Disinfectant Level Goal (MRDLG):

The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Treatment Technique (TT):

A required process intended to reduce the level of contaminant in drinking water.

MC:

Many compounds tested in this group, each have their own EPA assigned MCL and MCLG.

Action Level (AL):

The concentration of a contaminant which, if exceeded, triggers treatment or other requirements that a water system must follow.

- N/A: Not applicable
- ND: not detectable at testing limit
- ppm: parts per million or milligrams per liter
- ppb: parts per billion or micrograms per liter
- ppt: parts per trillion or nanograms per liter
- <u>pCi/I</u>: picocuries per liter (a measure of radioactivity)

Information about lead:

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Ford River Township is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you have a lead service line it is recommended that you run your water for at least 5 minutes to flush water from both your home plumbing and the lead service line. If you are concerned about lead in your water, you may wish to have your water tested. Service Material:

Our water supply has 90 unknown service lines that likely do not contain any lead, and 15 fully unknown service lines that may contain lead material. We also have 92 service lines that contain neither lead nor galvanized previously connected to lead, out of a total of 197 service lines.

Monitoring and Reporting to the Department of Environment, Great Lakes, and Energy (EGLE) Requirements: The State of Michigan and the U.S. EPA require us to test our water on a regular basis to ensure its safety. We met all the monitoring and reporting requirements for 2022.

We will update this report annually and will keep you informed of any problems that may occur throughout the year, as they happen. This report will also be posted online at <u>fordriver.org</u>

Previous Violations:

1. **Compliance Communication** – 2021 Consumer Confidence Report

Michigan Safe Drinking Water Act 1976, PA 399: R 325.10413, Annual consumer confidence reporting; content of reports. During the 2021 monitoring period Ford River Township failed to collect PFAS and Nitrate samples by September 30, 2021. To correct this deficiency and return to compliance, the Township collected PFAS samples on January 11, 2022, all resulting in Non-Detects. This monitoring violation was stated previously in the 2022 CCR. The 2022 compliance samples were taken on July 11, 2022 and results are reported within this CCR.

2. Violation Notice – 2021 Consumer Confidence Report

Michigan Safe Drinking Water Act 1976, PA 399: R 325.10412, Annual consumer confidence reporting; effective dates. Ford River Township did not distribute the 2021 CCR by July 1, 2022 as required. This violation was resolved and the Township returned to compliance on July 28, 2022 by providing EGLE with a copy as required.
