### WATER SYSTEM BUSINESS

Received the June 2013 Water Report. Moved G. Boudreau, seconded R. Fountaine, CARRIED, to accept the Water Report.

a. Estimated unmetered water usage for May is approximately 43%; Jeff received usage information from the clerk late and cannot at this time explain this large amount.

#### **NEW BUSINESS**

- a. Moved G. Boudreau, seconded R. Fountaine, CARRIED, to pay bills from the General and Liquor Funds totaling \$27,004.98 and bills from the Water System Fund totaling \$2278.86.
- b. Cemetery Ordinance: Discussed an inquiry from a resident as to whether a cremation burial is permitted in the same plot as a full burial. This is not currently permitted by our ordinance; the clerk will research cemetery ordinance terminology as used by other townships and suggested by MTA, and the board will review the entire ordinance.
- c. AT&T Metro Act Right of Way permit: Moved G. Boudreau, seconded S. Breitenbach, CARRIED, to approve extension of the Right of Way permit.
- d. CUPPAD membership: Renewal of membership is \$411. Moved G. Boudreau, seconded A. Wagner, CARRIED to renew our CUPPAD membership.
- e. Upcoming events: Discussed the Delta County Township Association picnic (Escanaba Twp) July 25th, no reservations required; Lion's Club fish boil August 4th, noon to 5:00; and our township ice cream social, August 25th, 1:00 to 4:00. All will be posted on the website.

## PUBLIC/BOARD COMMENT

- a. Request from clerk to purchase MTA FOIA book for \$25; Rachael will check whether it is different from one she already has. Moved G. Boudreau, seconded A. Wagner, CARRIED, to purchase FOIA book if we do not already have it.
- b. Supervisor Fountaine introduced Justin Zirkle, who will be opposing Ed McBroom for the 108th District State Representative; Mr. Zirkle provided us with his background information.
- c. Discussion regarding availability of a grant for dredging the mouth of the Ford River; water is low, causing difficulty for boats getting in and out. This was previously done by the DNR. Grants have been given by the State of Michigan to several other communities, and Escanaba is in the final stages of obtaining one; the money is apparently available but difficult to obtain, and could be looked into.
- d. Clerk Breitenbach introduced the new Deputy Clerk, Colleen Coppock.
