

Township of Ford River to physically remove the water connection to the public water service. The Township of Ford River, upon the advance payment by the consumer to the Township of Ford River of the estimated cost for equipment rental, time and materials necessary to undertake such action and any delinquent charges then due the Township of Ford River under the Water System Ordinance, shall remove the connection only during the period of May 15 through October 15.
