- Zoning Changes (By Attorney) Supervisor Fountaine provided the board with an updated copy of the zoning changes, as there were two things the attorney felt needed to be addressed, a copy of his email was provided and discussed. The board was also provided with a copy of the letter the Attorney sent to the Delta County Planning Commission, along with acknowledgement of their receipt of the updated ordinance.

She stated the current proposed ordinance changes have already gone through a public hearing, the Township Attorney and were with the County for review, if any additional changes were made at this time we would need to again follow through on all of these steps. The board and R. Fettig agreed that we did not want to re-visit those steps again and the list could be reviewed if ordinance changes were made in the future.

The board re-explained the addition of Section 418 A-4. Allowing a sign for an approved Special Use Permit.

- Marijuana Recommendation Supervisor Fountaine provided the board with a copy of the current Township Marijuana Ordinance. It states the Planning Commission must "Prepare and submit a report to the Township Board by March 11, 2020, with a recommendation as to whether the Township should authorize one or more types of marihuana establishments. If the Planning Commission recommends authorization, the report shall outline, in general terms, the recommended regulations."
