FIRE DEPARTMENT BUSINESS

- h. Generator A Proposal has been received from Cummins NPower, LLC in the amount of \$5,673.20 for a five year plan. Mark will get a quote for one year. Maintenance should be done every year. The Agreement can be cancelled at any time.
